**LIABILITY RELEASE AND ASSUMPTION OF RISK / COMPLIANCE MANDATORY**

In order to fairly and honestly inform you of the services Lazy River Canoe Rental (McClain's) provide, you should know and appreciate that participating and or use of any rental equipment during this trip involves certain specific risks and dangers, which are inherent in river travel or other activities associated with this event. These risks include loss of damage to personal property, injury, or fatality, collision with an object, immersion in water and hypothermia, falling while onboard a vessel or on shore, accidents or illness in remote places without medical facilities, and other unforeseeable events. There are no lifeguards posted along the river.

I, the undersigned, hereby acknowledge that I fully understand that there are inherent risks involved in river activities, as well as activities preliminarily and subsequent thereto, including but not limited to the transportation to and from the river and camping. I expressly covenant and state that I assume all risks for myself and children in my care.

I understand that the rates quoted to me are based on my assumption of said risks, and I specifically release Lazy River Canoe Rental (McClain's), its officers, employees, guides, agents, contractors, property owner from any liability as to any right of action or claim to relief that may accrue to me or my heirs or personal representatives for any such personal injury, loss of life, loss of consortium, or loss of or damage to property, including gross negligence or reckless misconduct, which I may suffer on said river travel, the transportation to and from the river, or other activities associated with the trip. The terms hereof shall serve as a release and express assumption of risk for my heirs, executors, administrators, myself and all members of my family including any minor accompanying me.

I further agree to be responsible for canoes, kayaks, paddles, life vests, and or equipment issued to me; I will inspect said equipment prior to using it in order to determine if it is in a safe condition of repair and seaworthy, and I agree to return it in the same general condition. I acknowledge that I and the children in my care, have received life vests and understand they are to be used. If we do not understand how the life vests are to be used we will ask Lazy River Canoe Rental (McClain's) personnel for proper instruction. Adults should buckle vest on children. We acknowledge that each person in or group understands how to wear the life vests issued and must keep your life vest on your person while in the vessel or recreating out of the vessel in or near water.
